Our work **does not** constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and **does not** provide the same level of assurance that such an audit would do.

2 External auditor report 2018/19

On the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with *Proper Practices* and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the authority:

- Whilst we have received evidence that the annual risk assessment was approved by the Finance and General Purpose Committee in June 2018,, the council has not provided sufficient evidence of consideration of risk management arrangements by the whole authority during 2018/19 prior to approving the response to assertion 5 of the Annual Governance Statement.. This was requested as part of our intermediate review procedures.
